



## LIMITED WARRANTY FOR SID SIGNS ENGRAVERS

Your SID Signs XL 1390 or XL 2513 Engraver, chiller, blower and air compressor (the Equipment) come with a one year limited warranty against defects in material and workmanship, except that the laser tube has a 6 month warranty. The warranty starts from the date of shipment from Paradigm Imaging Group or an authorized reseller. The warranty is limited to the original end user purchaser of the Equipment and is non-transferable to any subsequent purchaser. Proof of purchase may be required.

This warranty covers only those defects that arise as a result of normal use of the product and does not cover any other problems, including those that arise as a result of: improper shipping or installation; improper maintenance, modification or misuse; operation outside the product's specifications; or fire, flood or other acts of God.

**It is possible for the Equipment to start a fire when used improperly, not maintained properly, used on the wrong materials, and in normal use. It is mandatory that it is monitored at all times during use and safety precautions taken.** Paradigm Imaging Group and SID Signs are not responsible for any direct or indirect damage, caused by fire, to the Equipment, other equipment, persons or structure. In addition, Paradigm Imaging Group and SID Signs are not responsible for any injuries, loss of life or loss of business.

The warranty does not cover consumable items or supplies necessary to operate or maintain the Equipment. Please see the List of Consumable Items.

SID Signs and Paradigm Imaging Group do not warrant that the operation of any product will be uninterrupted or error free; shall not be responsible for any loss of business or production while the equipment is out of service; and, shall not be responsible for providing temporary replacement equipment or services to replace those lost.

The warrantability for any damage to the Equipment or parts thereof is at the sole discretion of the manufacturer. If the manufacturer determines that the damage was not caused by defects in materials and workmanship, the parts or repair will be charged at the then current rates. Any defective product or part will be repaired or replaced at the manufacturer's option. Any replacement part or product may either be new or like-new, provided that it has the functionality at least equal to the part or product being replaced.

Service and repairs must be performed by an authorized service technician only or after receiving approval from Paradigm Imaging Group. If Paradigm Imaging supplies a warranty part to the user for replacement, the replaced part must be returned to Paradigm Imaging Group.

The warranty covers the Equipment hardware. It does not cover computer, software, color or connectivity issues. It does not cover maintenance of accessories, attachments or peripherals. It does not cover painting or refinishing or materials for such.

The warranty is only valid in the United States and Canada.

It is understood that the equipment requires routine maintenance by the end user. Failure of the end user to perform this maintenance may void the warranty. Maintenance includes, but is not limited to, inspection and cleaning of mirrors and lenses, cleaning and lubricating the carriage rails, replacement of consumable items such as mirrors and lenses, and performing routine cleaning.

The warranty does not cover Equipment that has been altered in any manner, or for which the manufacturer's identification marks or serial numbers have been removed or altered.

#### **Limitations of Warranty**

Laser tubes are covered under this warranty against defects in materials and workmanship as determined by the manufacturer for a period of 6 months from the date of shipment. Paradigm Imaging Group and SID Signs are not responsible for laser tube failure caused by abuse, neglect, high or low water temperature or water that has not been changed on a regular basis.
